## **Vendor Exhibitor Rules & Regulations:**

1. Application must be postmarked by March 27, 2026.
2. Exhibitors can begin setting up no earlier than 5:00 AM Saturday, April 18. All vendors must be set up and ready by 9:00 AM. All vehicles must be off the streets and parked in designated parking areas by 8:30 AM. Festival hours are 9:00 AM - 4:00 PM. **Vendors Cannot Breakdown before 4:00 PM.**
3. This is an outdoor event which will take place around the Colquitt County Courthouse square and down side streets. There will be no refunds due to inclement weather.
4. Craft Vendors: Must display quality handmade arts and crafts only. Resale items (not handmade) are not permitted. Flea market items will not be accepted. The festival chairmen reserve the right to remove any item which does not maintain the quality of the show. Vendors displaying merchandise not listed on applications will be asked to remove items.
5. Information Vendors: Cannot sell anything or give out bottle water. Information vendors can hand out promotional products, information pamphlets, and can accept donations.
6. Craft Food Vendors: Must be prepackaged foods (Examples: flavored popcorn, pork skins, cakes, cookies, etc...) Craft Food Vendors must send in a copy of their Cottage Food License with application. Food cooked on site is Not Craft Food!
7. Photos must be included with your application. The pictures could be publicized and should display the arts & crafts you will be bringing to the festival. Event staff has the right to remove crafts that are unacceptable, which could result in a dismissal without a refund.
8. Spaces are 12x12. Any vendor needing additional space must reserve it on the application. 12x12 Spaces are \$100.00 without electricity and \$140.00 with electricity. You must bring your own extension cords at least 100 feet, tables, chairs, & tent with weights.
9. All vendors are responsible for collecting Georgia sales tax (8%).
10. No Refunds.
